Unspent **Structural Funds**

Sajjad has backed calls by the European Commission President, José Manuel Barroso, to use billions of pounds of unspent EU money on creating growth and jobs.

Currently there is #2billion of structural funds unspent across the EU with €.5billion in the UK, allocated mainly to the European Regional Development Fund (ERDF) and the European Social Fund (ESF).

"We need to use that money to help fund small businesses and help them obtain finance. said Sajjad "Small businesses are the driving force of our economy and visiting companies across the North West I hear the same thing over and over. Companies want to expand and employ more staff but the banks have a closed door policy. One and half billion won't solve the problem but it will help to ease the crisis. We must support our entrepreneurs and do what we can to ensure they have the tools to do the job.

"Member states have until the end of 2013 to draft, approve and implement new programmes to use the funds and I will be asking the UK to ensure the North West gets its fair share."

SIMPLIFYING VEHICLE REGISTRATION ACROSS THE EU

Sajjad and his Conservative colleagues in Europe have welcomed plans to make it cheaper and simpler to re-register a motor vehicle between EU countries.

Proposals from the European Commission would end the lengthy procedure in registering a vehicle according to national legislation. Currently it takes on average 5 weeks to complete at a high cost to both citizens and businesses.

CAMMELL LAIRD "A MODEL FOR ALL MERSEYSIDE BUSINESSES"

On a recent visit to Cammell Lairds' iconic site in Birkenhead, Sajjad toured the yard and saw sections being built for the new Queen Elizabeth Aircraft Carrier as well as ferries and RFA Wave Ruler being maintained for their maritime licenses.

Over a thousand skilled people now work at the site and last year Lairds put over fifty million back into the local economy. Commenting on his visit Saj said "A decade after the company went bankrupt and Laird's turnover is expected to pass £100 million this year for the first time. But what impresses me most is the commitment shown to the local community. There is a fantastic apprentice scheme taken from the local population and even the subcontractors tend to be Merseyside based.

"It was honour to walk the quays of the historic site and learn about future plans. Lairds work in a very tough economic market and has grown



itself out of difficulties and we can all learn from them.

Managing Director Linton Roberts and Finance Director Allan Wood showed Sajjad around the site following discussions on future projects. "It's very clear that businesses like Cammell Laird need new and more open markets in which to trade. I can assure them I have listened to their concerns and will do all I can to be a strong ally as they continue to rebuild the Cammell Laird brand" said Sajjad.

Welcome news for BAE Systems

Sajjad is currently undertaking a Fellowship with the Industry and Parliament Trust, part of which involves spending time at all the BAE Systems sites in the North West and he's welcomed recent good news for their three main plants.

A £1.6bn order for 22 BAE Systems Hawk Advanced Jet Trainer aircraft for the Royal Saudi Air Force has secured hundreds of jobs at their plants in at Warton and Salmesbury, near Preston and the aircraft will be delivered from 2016.

Meanwhile up in Ba<mark>rrow-in-Furness, the Government has announced it is handing a</mark> £328m contract to BAE to design the replacement of the Trident nuclear deterrent. Sajjad visited BAE Systems in Barrow earlier this year. He saw current Trident submarines under construction and discussed issues regarding future contracts with senior management. This new funding will help secure BAE's future as a major employer in Barrow for years to come.

Around 1,000 people work on the new class of submarines at the Barrow site, and in February BAE announced plans to create an additional 280 new jobs this year.

CONSUMER AGENDA

Sajjad has been at the forefront of a number of EU initiatives that aim to break-down the barriers for trade across the European Single Market.

In May, he gave his support to a new EU agenda setting out a range of initiatives to improve consumer confidence when buying from other countries within the EU. The agenda also aims to increase cross-border economic activity and boost economic growth across the continent.

The 'European Consumer Agenda' has been adopted by the European Commission to increase market confidence. These involve improving consumer protection rules when buying from another EU country; raising consumer awareness of rights when shopping across borders (including online); stepping-up enforcement and

securing redress, and aligning consumer rights and policies to changes in society and the economy.

Sajjad said: "The new European Consumer Agenda is not only an important step in further opening-up the Single Market for consumers, but also an important initiative that will help to foster economic growth across the EU.

"Consumers make-up a massive 56% of all EU GDP, yet many still find themselves held back, both physically and psychologically, from their right to shop across the EU. This ambitious agenda

aims to end that. "By giving consumers clearer and stronger protection when buying across Europe, especially when online, shoppers should feel as safe buying a product or service from another EU country as they should from their local High Street.

SAJJAD TOASTS CAINS SUCCESS

Ten years after Liverpool's Cains Brewery almost closed for good the company is predicting it will return to profitability next year. Sajjad visited the brewery shortly before Cains confirmed a nationwide deal with Tesco. 300 stores will stock a lower alcohol Calcutta Pale Ale created exclusively for Tesco

Established by Robert Cain in 1856, tight margins brought it to the brink of closure in 2002 and the Dusanj brothers stepped in. Cains is now one of the fastest growing

breweries in the country, with a £30 million annual turnover, 150 employees, and more than 120 million pints of beer brewed annually.

The first Asian family ever to run a British brewery, the brothers are building on the fine traditions of excellent quality ales.



Sajjad, who is also working on the new EU/India Free Trade agreement, said, "This is a fantastic acheivment. Cains is a great brand and important local icon. It was an honour to tour the brewery and learn about their operation."

BRINGING COMPETITION TO AUDITING

As Conservative Legal Affairs Spokesperson, Sajjad was this year appointed as the **European Parliament's lead negotiator on new** EU reforms that aim to inject competition into the audit market, which is currently dominated by just four big companies.

The reforms aim to give smaller firms the chance to establish themselves in the market through proposals that will force large businesses to rotate their auditors every six years and make public companies use two firms jointly. Restrictions are also being proposed to stop firms offering non-audit services (such as tax advice) to businesses if they are already providing them with audit services.

Speaking on the reforms, Sajjad said: "The Commission's proposals are radical and will force a major shake-up of the audit market. There are many big challenges ahead and there has been extensive lobbying from the big firms, though the key argument remains that it is in the public interest to have more players in the market.

It is with this background that the parliament has introduced the first ever code of conduct for members." - Sajjad Karim is the only British MEP to sit on the European Parliament's Advisory Committee of the new MEP code of conduct.

The Advisory Committee will police new rules and Sajjad is one of only five MEPs to be appointed by the Parliament's President to this panel which advise him on what steps to take in the event of alleged breaches of the code.

The new code of conduct came into force on January 1st this year and aims to strengthen and clarify existing rules. The Constitutional Affairs Committee has compared the new rules with national equivalents and aims to guarantee the highest level of transparency. This includes an explicit ban on receiving payments or other rewards; clear rules on the acceptance of gifts, and rules governing former MEPs who work as lobbyists.

Sajjad said, "The relationship between public and politician has been at an all-time low. A small number of MEP's have been accused of corruption and we all have our own national stories, such as the Westminster expenses scandal of 2009

"This code of conduct demands transparency from Members right across the continent and will provide a strong shield against unethical behaviour. Embrace the code and we become a part of the solution. This should go some way to restoring the public's trust."

FIGHTING **EXTORTIONATE** INTERNATIONAL **PHONE BILLS**

A major shake-up in the mobile market means cheaper phone calls and data downloads for North West holidaymakers travelling in Europe, from July. Customers can sign-up to a second mobile provider when travelling abroad, as an alternative to their UK service-provider, and still be able to use their same number

Saj believes these new plans approved by the European Parliament in May, will help tackle the root cause of high roaming prices by bringing real competition to mobile communications across Europe. This will drive down prices for voice and data services to people travelling for leisure or business. With the cost of everything going up this is a rare piece of good news for consumers.

Saj said the proposals are a positive example of how the European Union and the single market can benefit its citizens. "It's a welcome step and marks the end of the unwelcome "bill shock" when people come back from a holiday, but service providers themselves should be doing more to lower their prices."

Saj is supporting the Manchester Debating Union's bid for the European Universities Debating Championship 2013 to be held here in Manchester and has pledged his full support to the bid.
