FESTIVE WARNING! Sajjad echoes calls from Trading Standards warning people to beware of loan sharks operating in their neighbourhoods and amongst families and friends.

Loan sharks are illegal money lenders who often prey on vulnerable and hard-up members of the community during the Christmas period. They are notorious for charging enormous amounts of interest over long periods and often use threats and violence to intimidate their victims into coughing up more cash.

Sajjad has urged North West residents to steer clear of these illegal lenders and to report them to Trading Standards immediately.

If you have borrowed from an unlicensed lender you have not broken the law, they have. To report a loan shark you can:
